A. Lippert welcomed Barry Coulson, Director, Finance and Wendy Lannard, Director, Facilities who were in attendance to make a presentation at the in-camera session.

A. Lippert welcomed new board members Stacey Edzerza Fox, Jeff Lowe, and Jas Sandhu, who were appointed to the Board on August 1, 2012, replacing a vacancy from the previous year and vacancies due to the departure of Ross Clark and Dennis Dineen, who each completed their six-year term with the board.

D. Ross introduced and welcomed new executive members, Dr. Brad O'Hara, Vice-President, Academic and Provost who commenced his position on August 15, 2012; and, Dawn Palmer, Associate Vice-President, Human Resources who commenced her position on July 1, 2012.

1. APPROVAL OF THE AGENDA

2. APPROVAL OF THE MINUTES and BUSINESS ARISING

a) Minutes of the Meeting held on June 21, 2012

3. CHAIR'S REPORT

a) Community Connections

A. Lippert reviewed the activities as noted in the Community Connections memo attached to the agenda.

She reminded Board Members of the importance of their participation in events organized by the College as a way to become more familiar with the work of the College and also with the members of the College Community.

b) Letter from the Minister of Advanced Education dated August 28, 2012

A. Lippert highlighted a letter attached to the agenda from the Minister of Advanced Education addressed to the Board Chairs dated August 28, 2012 regarding the Adult Entertainment Industry and recruitment strategies at post-secondary job fairs.

Members were advised that Langara has a planning committee for its career/job fairs to ensure that invitees represent a wide range of economic sectors as well as non-profits. As a separate measure, job vacancies are solicited all year through the student employment website where employers electronically submit forms outlining their vacancies. Jobs are not posted until they have been vetted for ethics.

c) Committee Membership 2012/13

A. Lippert advised that the committee membership list for 2012/13 is under revision due to the change in Board membership. The document will be updated and distributed to all board members.

d) Meeting Schedule 2013

A. Lippert advised that the Board meeting schedule has been set for the balance of 2012 and 2013 as identified in the document attached to the agenda.

A. Lippert advised that John Yap, new Minister of Advanced Education, Innovation and Technology and Minister of Multiculturalism, contacted her to introduce himself and she welcomed him on behalf of the Board.

4. PRESIDENT'S REPORT

D. Ross referenced his memo dated September 21, 2012 attached to the agenda which highlighted College events that occurred from July - September 2012.

D. Ross reported on the following:

- Supreme Court decision regarding Access Copyright;
- Federal movement regarding Visa applications for international students applying for work;
- Federal Government's international education policy to double enrolments by 2020;
- Debbie Azaransky appointed Acting Executive Director, Lower Mainland Branch of the Ministry of Advanced Education;
- Moira Stilwell, MLA, Vancouver-Langara appointed Minister of Social Development;
- The launch of the Nunavut project with the first faculty cohort going in October;
- The opening of the Learning Commons space in the Library;
- Langara as the first college to launch the bioinformatics program in western Canada;
- Domestic and International Enrolments; and,
- Provincial Budget 2012/13.

D. Ross noted that student governors T. Lu and M. Otaka will be completing their one-year term on the Board shortly, with this being their last meeting.

An expression of thanks and appreciation was conveyed to both and it was noted that T. Lu is running for re-election.

a) Board Coordinating Committee

A.
