Acceptance into the RMT Program is based on an assessment of your transcript, and individual course information from another school. There is no mandate for massage therapy education programs to deliver required courses in a standard format, and some material included in the Langara RMT Program equivalent courses may not be covered by your previous institution. Prior learning assessments are based on information that you provide.

<u>INTERNATIONAL STUDENTS PLEASE NOTE:</u> International students transferring from a "private" RMT Program (ie: all RMT programs in BC, other than Langara) will **NOT be eligible** for the Canada Immigration 3-year post-graduation work permit. International students who wish to be eligible for this post-grad work permit must complete the entire 2-year program of studies at Langara to comply with the Canadian Immigration requirement.

DEADLINES

- Transfer credit requests take <u>8 weeks</u> to process.
- Requests and all supporting documents must be received at least two months before the beginning of the semester in which you wish to enroll. This is to ensure that any prerequisites you require for registration will be on your student record.
 - May 15, for September Registration
 - August 15, for January Registration
 - January 15, for May Registration

FEES

- \$350.00 per assessment for program completed at a BC institution
- \$400.00 per assessment for program completed at an institution outside of BC

RESTRICTION

- You must complete at least 50% of the Langara RMT Program in order to receive a Langara CS Diploma in Registered Massage Therapy. Please refer to the Langara College website at www.langara.ca for program information.
- Only courses completed with an equivalent passing grade (75%) are considered for transfer credit, and must be completed within 5 years.

Students must sign the Waiver on the second page of this form indicating that they understand, and agree, that Langara College is not responsible for any missed material that may result in failure to pass the BC Provincial Registration exam administered by the College of Massage Therapists of BC.
